

MIT Alumni Association

During president L. Rafael Reif's inaugural year, the [MIT Alumni Association](#) helped introduce him to the global alumni community in several ways. The inauguration itself, with a theme of "One Community, Together in Service," was held in conjunction with the Alumni Leadership Conference, in September. Combining the two events added a festive atmosphere, underscored the importance of the worldwide MIT community, and boosted attendance. President Reif also engaged alumni through a series of live, half-hour webcasts hosted by the Association. On three winter dates, President Reif responded to alumni questions, both those solicited before the event and live questions. Nearly 800 alumni registered to participate in the exclusive broadcast and more than 500 logged in for the webcasts on MIT's global impact, research mission, and educational experience. Alumni from 39 countries and 42 states took part in the webcasts, which were staged at different times to accommodate global viewing audiences. The [archived webcasts](#) have been viewed more than 1,400 times since the event.

The MIT Annual Fund completed another successful year, exceeding its original goal of \$53.6 million with a record-breaking total giving of nearly \$58 million.

The Association, with MIT, is working to increase the engagement of the 128,583 living MIT alumni. To document that work, it tracks face-to-face interactions, virtual interactions on the Infinite Connection website, and donations to MIT. This year, 48% of alumni participated in at least one of those ways. Community mindshare—alumni who participate in all three ways—reached 8%.

The alumni body in brief is composed as follows: 79% are male, 51% have graduate degrees only, and 14% are international. By School, 47% hold engineering degrees; 21% science; 17% management; 7% architecture; 5% humanities, arts, and social sciences; and 3% other. The Association maintains contact information for 95% of alumni.

Key Accomplishments

- The MIT Annual Fund set a new record for the total number of alumni donors to the Institute in any single year, with 32,986 alumni counted. Overall, the fund set a new record for total number of donors from all categories, with 43,561 donors—a 6% increase over last year.
 - The Class of 2013 set a new record, reaching a remarkable 83% participation in its Senior Gift Campaign.
 - Reunion giving topped \$135,431,580, with four classes breaking records for total dollars.
- The Association produced a total of 1,202 events worldwide, an increase of 15%; 42,504 alumni and guests attended these events.
- The 182 alumni education programs, both face-to-face and online events, featured 66 faculty members, 21 academic leaders, and 113 alumni speakers. Worldwide, 5,785 alumni registered for live events and 4,561 for virtual events.

- Tech Reunions, held June 6–9, offered 156 events. The 3,697 participants, the second highest total ever, came from 45 states and 24 countries.
- During Technology Day, which was presented in Kresge Auditorium to an audience of some 1,400 alumni and guests (also webcast worldwide), six faculty addressed the topic of unraveling the workings of the brain.
- Alumni engagement in reading the *Slice of MIT* blog and participating in the Association’s social media channels grew noticeably: for example, views of *Slice* stories grew 27%, while Association Facebook likes were up 45%.
- Reorganization and expansion of the clubs and affinity groups managers into the Geographic Communities team helped increase local events to 929 and encouraged the adoption of Encompass online communications tools.
- Alumni Travel Program participants increased 29% this year, totaling 636 alumni and guests on 37 trips.
- Engaging graduate student–exclusive (GSE) alumni (those who did not earn undergraduate degrees at MIT), who are now 51% of all alumni, is a high priority. Special programming included Technology Day events and a celebration of graduate alumni who started in the biology program 25 years ago.
- The Legislative Advocacy Network issued two calls to action and held its first network webinar, offering insights on sequestration’s potential impact on MIT’s research programs.
- Volunteers increased by 8% this year, with 13,187 alumni and friends working on behalf of MIT and the Alumni Association in projects ranging from organizing reunion activities and giving to interviewing prospective students.

Annual Giving

FY2013 was another banner year for the MIT Annual Fund, which recorded nearly \$58 million in gifts to MIT. The goal for the overall number of donors was an aspirational 43,021—an expression of the MIT Annual Fund Board’s desire to maintain the momentum generated during MIT150. The fund stayed on pace with that vision and exceeded its target, reporting a total of 43,561 donors, an increase of more than 5%.

Overall alumni participation reached 28%, with FY2013 undergraduate alumni participation up slightly, to 35%. The GSE alumni participation totaled 22%.

In other highlights, the Parents Fund, led by John Begg ’78, P ’10, P ’14, set a new dollar record, reporting more than \$1.8 million. The Class of 2013 achieved a record-breaking 83.1% participation in its Senior Gift Campaign, raising the bar for future graduating classes. Meanwhile, boding well for the future, 47% of all underclassmen at MIT participated in the Underclassman Giving Campaign, in support of expedition grants for fellow students through the MIT Public Service Center.

For the first time since FY2007, the 10 youngest classes of undergraduate alumni broke the 30% mark, reporting 31% participation. They were aided by a new challenge program: Prisca Chen Marvin ’85 offered MIT10 alumni matching gifts based on

reaching participation benchmarks. Young alumni dollars are also significantly up this year to more than \$635,000.

Four Reunion Gift Campaigns set new dollar records, including the 30th reunion Class of 1983; the 35th reunion Class of 1978; the 55th reunion Class of 1958; and the 75th reunion Class of 1938. The total of all reunion gifts stands at \$135,431,580.

The William Barton Rogers Society (WBRS) grew again in FY2013, reporting a record 6,764 members, relative to the prior record in FY2012 of 6,414. As the society matures, it continues to correspond nicely with the expansion of donor engagement in conjunction with the campaign.

The 1861 Circle completed its fourth full year honoring MIT's most loyal donors—those who have given consistently on an annual basis of five or more years. Once again, the loyalty factor continues to climb. In FY2013, the group expanded by just over 4%, to 17,946.

A considerable increase in the number of friends—the result of a more robust effort to reactivate past friends donors—helped fuel the significant overall progress in the donor number from 2,286 last year to 4,031 in FY2013.

An imperative of the MIT Annual Fund is to more effectively engage donors in supporting the unrestricted fund, to provide the Institute with the greatest flexibility to apply gifts where they are most needed. The MIT Annual Fund reported an 11% increase from FY2012 to FY2013 among alumni, students, parents, and friends who supported the unrestricted fund, bringing the total to 16,182 donors.

Finally, as the MIT Annual Fund grew and realigned its resources to work closely with the larger Resource Development effort, two new units were formed—the Annual Leadership Giving Office, which will focus on building individual relationships and soliciting donors capable of gifts in the \$5K–\$100K range (working in concert with the Office of Leadership Giving) and the MIT Annual Fund Stewardship Office, which is part of the larger marketing and participation team, and manages the William Barton Rogers Society (including a robust schedule of WBRS receptions and events), the 1861 Circle, stewardship of class and club projects, and other important engagement opportunities.

The fund also completed expansion of the tech caller facility and conducted an audit of current marketing practices. The mantra of the fund has become “reaching the right people with the right messages at the right time through the right channel.”

Events

Face-to-face events are a vital way that the Alumni Association builds community and connection. In addition to Tech Reunions and club, class, and other affinity group events, the Association hosts Family Weekend and the Alumni Leadership Conference.

Tech Reunions

An early weekend torrential rainstorm did little to dampen the spirits of some 3,697 alumni and guests who returned to campus for Tech Reunions 2013, held in June. This year's reunions drew the second highest attendance ever, second only to the sesquicentennial celebrations in 2011. The Class of 1993 and the Class of 1963 had very high attendance. A special GSE alumni track, hosted for a second year, drew registrations from 164 graduate alumni and guests. Some 327 volunteers helped with the festivities.

Tech Reunions offered 156 events for participants, who came from 45 states and 24 countries. Some 1,200 people registered for Toast to Tech, a complimentary late night beer and wine reception, held on Saturday night. Guests at the 116th Tech Night at Pops filled Symphony Hall to hear professor John Harbison and the MIT Vocal Jazz Ensemble perform "Rhumba for Rafael Reif" and an arrangement of "Arise All Ye of MIT."

During the Technology Day Luncheon, the Alumni Association announced its newest honorary members: Larry Anderson, associate professor of the Department of Athletics, Physical Education, and Recreation (DAPER) Intercollegiate Sports, and head coach of the MIT men's basketball team; Cardinal Warde, professor of electrical engineering and computer science; and Sean A. Collier, the MIT campus police officer killed in the line of duty, on April 18, 2013.

Education Programs

Of the 182 programs this year, 11 were virtual, consisting of seven Faculty Forum Online events, three broadcasts of President Reif, and the broadcast audience for Tech Day. The seven Faculty Forum Online programs had a total of 3,146 alumni registrants, for an average of 449 per event; the three President Reif broadcasts netted 777 alumni registrants, or 259 per broadcast; and there were 638 alumni registrants for the Tech Day program.

Technology Day focused on the Department of Brain and Cognitive Sciences, in a program titled "Unraveling the Workings of the Brain." Moderated by department head James DiCarlo, the event featured presentations by faculty speakers, including "The Brain as Computer," by Joshua Tenenbaum PhD '99; "The Brain as Mind," by Rebecca Saxe PhD '03; "The Brain as Decision Maker," by Drazen Prelec; "The Brain in Suspended States," by Emery Brown; "Dissecting the Brain," by Alan Jasanoff; and "Engineering and Reverse Engineering the Brain: Controlling the Brain to Understand and Fix It," by Edward Boyden '99, MEng '99.

Faculty Forum Online, offered monthly throughout the academic year, invites alumni to view a live, half-hour interview with a faculty member discussing a timely topic and to ask their own questions. Speakers included Andrea Campbell, on taxation and health policy; Daniel Cziczko, on cloud formation; Andrew Whittle ScD '87, on coastal flood protection; Kerry Emanuel '76, PhD '78, on a new approach to climate science;

Christopher Knittel, on climate change and economics; James DiCarlo, on brain research; and [James Walsh PhD '00](#), who discussed the volatile politics of North Korea.

Three View from the Top programs drew a combined 350 alumni registrants. In each city, a panel of outstanding alumni discussed compelling topics. In October in New York City, the panel was titled “Global Capital Markets: What Next?” Speakers included Armen A. Avanesians '81, managing director of Goldman Sachs Asset Management, and Leslie Rahl '71, SM '72, managing partner of Capital Market Risk Advisors. An April event, titled “Innovative Thinking: Chicago Style,” presented speakers including Michael Evans '99, MEng '00, cofounder and president of GrubHub, and Smita Shah SM '96, founder, president, and chief executive officer (CEO) of SPAAN Tech, Inc. In June, the panel “Seattle: Reinventing the World” included Yin-Ling Wong '04, senior program officer at the Bill and Melinda Gates Foundation, and Margaret A. Orth SM '93, PhD '01, founder and CEO of International Fashion Machines.

Other Gatherings

Toast to IAP (Independent Activities Period), is an annual program that targets MIT alumni who graduated in the last 10 years. Via pub nights and gatherings held around the world on the same night, it saw an increase in events, from a total of 64 in 2012 to 71 in 2013.

Summer Send-Off events—an excellent way to bring together alumni with current students, new students, and MIT parents—held steady, with a total of 45 events this year.

Giving societies gathered leadership and loyalty donors at festive events through the year. WBRS held events in New York, San Francisco, Washington, DC, and Cambridge, and partnered with the MIT Sloan School of Management for a joint event in London. The Cambridge event, a joint WBRS and 1861 Circle reunion gathering, drew more than 400 alumni and friends.

The Association and local clubs hosted chancellor Eric Grimson PhD '80 at an October event in Germany, and at February events in Palm Beach, Miami, and Southwest Florida.

Five affinity groups were active this year. The Association of MIT Alumnae; Black Alumni of MIT (BAMIT); and Bisexual, Gay, and Lesbian Alumni of MIT held events, as did the re-energized MIT South Asian Alumni Association (MIT SAAA). The MIT Arab Alumni Association held its signature international conference in the spring.

Family Weekend 2012, hosted by the Association for current students' families, welcomed 659 families and 1,916 individuals to campus.

Travelers on 15 Alumni Travel Program trips had the opportunity to meet with local alumni and MIT students joined a festive travelers' dinner in Berlin, thanks to a new collaboration with the MIT International Science and Technology Initiatives program.

Travel

The MIT Alumni Travel Program made the strongest rebound since FY2008, with 636 travelers, who embarked upon 37 trips worldwide.

Faculty led 14 trips comprising 285 travelers. During two different trips, 40 MIT alumni and guests viewed the total solar eclipse in Australia in November under the leadership of physics professor Edward Bertschinger and planetary sciences professor Richard Binzel. MIT travelers learned about DNA and the molecular basis of evolution from biology professor Graham Walker while exploring the Galápagos Islands. Travelers learned about volcanoes in Costa Rica with professor emeritus of geology Frederick Frey. During an MIT custom-built trip, 18 alumni and guests took a private tour of the Laser Interferometer Gravitational-wave Observatory (LIGO), in Louisiana, with professor emeritus of physics Rainer Weiss '55, PhD '62. Nuclear engineering professor Michael Golay accompanied travelers in Japan and spoke about the Fukushima Daiichi nuclear power plant disaster. MIT faculty also joined travelers on ventures to India, Cuba, Tahiti and French Polynesia, Patagonia, Italy, Spain and Portugal, Provence, and the Mississippi River.

Travelers had the opportunity to meet local alumni during 15 trips. During the LIGO trip, Seth Knudsen MCP '08, project manager at the New Orleans Redevelopment Authority, described his work on affordable housing in New Orleans. Shanghai residents joined US travelers to celebrate the Fourth of July during the China Family Program. A tour of a local hospital was arranged with the help of an alumnus who is chief of pediatrics in Arusha, Tanzania. Three local alumni in Northern California hosted an MIT group biking through Sonoma Valley at their wineries. Other local visits included international stops in Sydney, Delhi, Ankara, Istanbul, Aix-en-Provence, Madrid, and Berlin. On two separate trips to Cuba, 58 travelers met with local citizens.

In FY2013, 37% of travelers were Graduate Student Exclusive alumni; 17% were repeat travelers. This percentage of participation has been fairly steady throughout the travel program's 22-year history.

Engagement/Advocacy

Alumni are MIT's best ambassadors in their workplaces and communities. The Association provides opportunities to get involved in interest groups, interview prospective students, and share stories that illustrate MIT's mission in the world.

Special Interest Networks

The K–12 Science, Technology, Engineering, and Mathematics (STEM) Education Network now has 903 members, a 39% increase over last year. The K–12 STEM Education Facebook page is extremely active, with “likes” growing this year by 55%, and Twitter account followers grew by 150%, to nearly 2,200.

The K–12 STEM working group added committees for communications, club connections, campus connections, and the For Inspiration and Recognition of Science and Technology (FIRST) Alliance.

At the Alumni Leadership Conference, two key volunteers, Henry Houh '89, '90, SM '91, PhD '98 and Nadine Otterman '92, along with professor emeritus Woodie Flowers SM '68, ME '71, PhD '73, talked about their involvement with FIRST.

This year, at the FIRST Championships in Kansas City, MO, an event for admitted students and alumni, attracted more than 200 people who heard from professor Mitchel Resnick SM '88, PhD '92, head of the Media Lab's Lifelong Kindergarten group. Four alumni staffed the MIT booths and led hands-on STEM demonstrations.

Alumni clubs recognized 29 MIT Inspirational Teachers, including Yong Joo '95, who was nominated by engineering undergraduate Elisha Gray for outstanding teaching at Alameda High School in California.

Sixteen alumni clubs sponsored teachers from their communities to attend the Science and Engineering Program for Teachers, a weeklong summer program on campus that highlights how engineers apply the principles of science to meet society's technology needs.

The Energy, Environment, and Sustainability Network now has 1,793 members, a 28% increase over last year. Working with the MIT Energy Club, the working group members again provided a booth for the annual MIT Energy Conference. They also suggested network members for the MIT Energy Club's mentoring program.

The energy ambassadors from alumni clubs in Northern California, Boston, Puget Sound, South Texas, New York City, and Southern California met by teleconference quarterly to share best practices for increasing energy-focused events in the various regions. With support from the MIT Energy Initiative (MITEI), several faculty speakers provided MITEI on the Road seminars, which had excellent responses from local alumni.

John Gavenonis '98 continued efforts to build the Legislative Advocacy Network, which currently includes 341 members, a 46% increase over last year. Given the concern over the US federal budget and plans for sequestration, two separate calls to action were sent to network members and the first network webinar was held, with Institute vice president Claude Canizares and Washington, DC, office director William Bonvillian offering insights on sequestration's potential impact on MIT's research programs. The calls to action included potential letters to Congress, as well as sample correspondence for local newspapers that alumni could use to update their own communities on the seriousness of the sequestration issue.

Student Engagement

In its sixth year, the Alan '73 and Terri Spoon Community Catalyst Leadership Program engaged 91 students from the Classes of 2013–2015.

The Student/Alumni Externship Program again broke the record for participation, with 183 alumni sponsors working with 332 students during IAP 2013.

Working with the senior class president, the Association sponsored two Senior Week programs, including a Toast to the Class of 2013 with Chancellor Grimson.

In an effort to engage more graduate alumni, special programs were created for graduate alumni on Technology Day, such as a collaborative gathering with the Chinese Student and Scholars Association and a poster session showcasing current graduate students' research.

Communications to current students is now highly customized. Every email was personalized with log-in information, and 87% of the Class of 2013 graduated with an Infinite Connection account.

Communications

In FY2013, the Association continued to expand virtual engagement through the Internet and social media.

Slice of MIT, the Association's daily blog, drew 456,691 views this year, an increase of 27%.

The Association engaged Corey McPherson Nash to develop a cohesive visual system and messaging standards for our marketing efforts. Corey is a national branding and design firm that helps organizations engage audiences across print, web, and social media channels. Consistent messaging and a brand identity system will be an important foundation to demonstrate the comprehensive work of the Alumni Association.

The Association edits *Technology Review's* Alumni Connection pages in the MIT News section and publishes 36 alumni profiles each year in the Class Notes/Course News areas. In FY2013, profiles included four-star general Janet Wolfenbarger SM '85; Paul Chrisman PhD '76, a National Fiddler Hall of Famer performing as Woody Paul; former blackjack ace Semyon Dukach SM '93, now an angel investor; foreign policy expert Ali Wyne '08; Brazilian entrepreneur Bel Pesce '10; and David K. Lam SM '70, ScD '74, founder of a global semiconductor lithography firm. These profiles are popular on the Association website as well.

Activity on the Association's Infinite Connection website, which contains the online alumni directory and access to many services, grew to 46,375 logins from alumni, students, and others. More than one million website visits resulted in 3,350,125 page views. Further, 36% of all gifts were made online. Mobile device use grew 134%, with 75,686 website visits.

The Association uses an array of e-newsletters to deliver news and useful information in a timely way. *Tech Connection*, the monthly email newsletter for all alumni, conveys research, Institute news, and campus culture to 90,000 readers. A digest version of *Tech Connection* was developed for Friends of MIT this year. *Volunteer View*, the e-newsletter for the more than 10,000 alumni who work with their classes and clubs or as educational counselors, provides tips for effective community building and connects the volunteer community. A regional monthly e-newsletter, sent in conjunction with the MIT Club of Boston, updates local alumni about club and campus events.

In the Association's second full year using the iModules Encompass software, email communications showed two key gains over the preceding year. The Association sent 3,279 mass emails (to 10 or more recipients), about 250% more than were sent in FY2012. Despite the large increase, mainly due to the growth of new subcommunities, the Association grew its average open rate by 2% and reduced the unsubscribe rate by 7%.

Program Outreach

The Geographic Communities team played an integral role in continuing the migration of clubs and groups to Encompass services, including website, event management, membership management, data management, and email marketing. The team supported these advances:

- Fourteen additional clubs (seven international) were migrated to Encompass this year, bringing the total to 50 clubs.
- Two additional affinity groups (MIT SAAA and BAMIT) migrated in the spring.
- A pilot project using the Encompass Groups function in areas that have no active clubs, but do have an MIT representative.

The Alumni Association hosted 30 colleagues from across the Institute for a networking breakfast to provide contacts and information about Association services and outreach; those services can be tapped through a new [Department Resources website](#).

The Parents Association Facebook page grew from 400 members to 725, as a dynamic resource for parents. A new Class of 2017 Parents Facebook group drew 338 members, and a new MIT Parents LinkedIn group garnered 130 members.

Tech Reunions offered a mobile application for the third year and participation increased; the FY2013 app was downloaded by 764 users who clicked on 34,852 pages.

Volunteering

Volunteers continue to power the MIT Alumni Association and all its activities. Every club and class activity, every interest and affinity group, every mentor and externship

opportunity is possible because of the countless hours alumni and friends devote to MIT. The total numbers of volunteers who worked on behalf of MIT and the Alumni Association increased this year by 8%.

- 43% donors

The Alumni Leadership Conference was held in conjunction with the inauguration of President Reif, providing the attendees with an inspiring backdrop to the community-building weekend. The conference, which had record attendance, brought 555 key volunteers and friends to campus. The inaugural theme, “One Community, Together in Service,” united alumni throughout the weekend as they heard from key faculty, students, and fellow volunteers.

Annual awards recognize the valuable contributions volunteers make to MIT and the Association. The Bronze Beaver Award, the Association’s highest award to exceptional volunteers, went to two outstanding volunteers:

- Cordelia M. Price ’78, SM ’82 has served as an educational counselor, a student advisor, a BAMIT officer, an MIT Club of Delaware Valley officer, and on her class reunion committees and the Association board. She also chaired the Ad Hoc Committee for Alumni Involvement in the 150th Anniversary of MIT.
- G. Mead Wyman ’62 has been the Class of 1962 president for eight years and also frequently serves as reunion chair. He has been a co-chair and participant in the biannual men’s basketball reunions, and has also served as a member of the Annual Fund Board, the *Technology Review* Board, and the Corporation Development Committee.

The Clubs and Regional Programs team was restructured as Geographic Communities, to broaden support for MIT alumni clubs and affinity groups on a regional basis.

Some 4,275 alumni served as educational counselors worldwide, interviewing prospective students, recruiting, and serving as resources in their communities.

Governance and Infrastructure

Chiquita White ’85 served as Association president during FY2013. White, who began volunteering for MIT immediately after graduation, has served as president of the Black Alumni of MIT, on the Alumni Association board of directors, and on the MIT Corporation and its executive committee. During her one-year term as president,

she worked with the board to revise the Association's bylaws to streamline business practices and make committees more flexible.

Particular bylaw changes include making board and Alumni Association Selection Committee membership independent of geographic districts; instead, multiple dimensions of diversity will be considered in selecting new board members and a preferential voting system will be used on the Alumni Association Selection Committee ballot. Two new board committees were created: the Nominating Committee, to generate candidates for Association roles; and the Program Committee, to review the Association's offerings.

White presented the gavel to incoming president John W. Jarve '78, SM '79 at the Technology Day Luncheon. Jarve, a venture capital professional and a key volunteer in the Northern California region, took office on July 1, 2013. He has served on the Alumni Association board of directors and on the MIT Corporation, and his work was recognized with the Lobdell Award in 1991 and the Bronze Beaver Award in 1998. The president-elect, who will take office July 1, 2014, is **Donald E. Shobrys '75**. Shobrys is codirector of the MIT Venture Mentoring Service, after a career in supply chain management. He has a civil and environmental engineering degree from MIT, a master's in civil engineering from Northwestern University, and a PhD in operations research from Johns Hopkins University. He received the Bronze Beaver and Henry B. Kane '24 Awards. He is a past chair of the Annual Fund and also serves on the Corporate Development Committee.

Four committees provide strong nominations for key volunteer roles, including membership on the board of directors and the MIT Corporation visiting committees, and for awards: the Alumni Association Selection Committee, the Awards Committee, the Committee on Nominations to Corporation Visiting Committees, and the MIT Corporation Screening Committee.

The Association works with the MIT Corporation on the annual ballot for the selection of a recent graduate member of the Corporation. Paul M. Kominers '12 was selected by fellow recent graduates and appointed by the MIT Corporation.

Infrastructure

The migration to AdvanceWeb, nearly complete, is the signature project of the year for the Information Systems and Services (IS&S) group. This joint MIT Alumni Association–Resource Development project was put on the fast track to be ready for the upcoming campaign. AdvanceWeb streamlines the process of accessing data for critical purposes.

The Networking team within IS&S accommodated 21 new/temporary staff hires and 24 office moves during the course of the year. Major upgrades/enhancements were made in the campus call center, including the installation of nine new stations and a server upgrade.

Several important enhancements were made with regard to the Advance database, the database of record for the entire Institute. Recurring gift payments are now possible through the Advance interface. Approximately 3,000 Sloan affiliates were loaded into the database, making integration more seamless.

Online systems also were improved. Single sign-on now allows alumni to access various sites without the need for multiple logins. The ability to make gifts to Donor Advised Funds is now possible on the Giving website. A better and faster online directory, with enhanced search capabilities, is now available for alumni. Finally, current contact information is maintained for 95% of alumni!

The Reunions team successfully migrated the remaining class pages to Encompass. In the spring, classes were introduced to the Encompass email marketing system and many now use it exclusively.

Budget Summary and Personnel Update

In FY2013, the Association's total expense budget was \$13,153,645. The Institute provided general Institute budget funds of \$12,913,708 for Association programs, which included \$1,879,709 allocated for subscriptions to *Technology Review* magazine. The budget was balanced with \$115,000 from the Association's reserves and \$124,937 from program revenues. The Association closed the fiscal year with a surplus of \$672,107, of which \$115,000 was returned to its reserves.

The Association's total headcount at the end of FY2013 was 89, compared with 76 at the end of FY2012. The Association hired 13 new staff, replaced 15 colleagues, and promoted 11. Also, the Association recognized seven staff members with Infinite Mile Awards and gave out 33 Spot Awards during the year.
