Michael –

We have held a number of meetings with Bon Appetit and they are going to provide meals for the student athletes who are returning to campus in August for pre-season practices. They are intending to charge us for the meals at a rate of \$10.00 for catered meals (2 – week 1 – Aug. 20-24) and \$11.00 for the meal ticket dinners (3) in the dining halls (Week 2 – Aug. 27-31) We estimate that there will be approximately 275 student-athletes at the catered meals (Week 1) and since the first year students have meals provided during Orientation, we will only be providing funds/tickets for approximately 210 returning/upperclass student-athletes

If this is something the UA is interested in partnering with DAPER, we can transfer funds to support this initiative. If the UA does want to support this, I want to make sure the message gets out to the coaches and the student-athletes that the UA is our partner in this, so we will need the appropriate lead time.

My hope is that this initiative to support a large number of our student-athletes is something the UA is interested in doing and that your response will come quickly so that we can move this forward and give credit to the UA. I will look forward to hearing from you – thanks!
